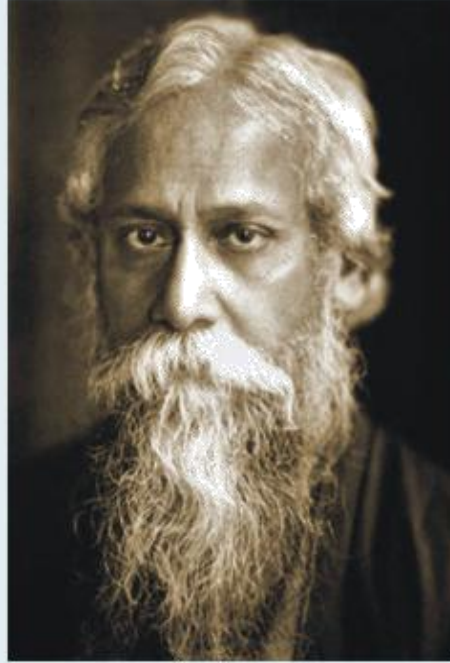


## *The School Motto*

## VIDYASAGAR SHISHU NIKETAN

**V**idyasagar Shishu Niketan is run by the Society for the Betterment of Education, Midnapore which was formed by a group of educationists and administrators on 4 September 1974 with the active help and encouragement from Sri Dipak Ghosh I.A.S, the then District Magistrate of Midnapore to impart better education to the school going children of Midnapore Town and to establish institutions for this purpose. This group felt that our children should be able to feel at home anywhere in India during their student life and also later in their working life. For this reason, they decided to set up a school where education would be imparted through the medium of English.

Vidyasagar Shishu Niketan was established in January 1975 with preparatory and kindergarten classes only, under the able guidance of Miss S. Mukherjee, Hon'y Secretary and Principal, herself a teacher of great distinction.

The School is now run in 4 sections (1) Pre- school section (Lower & upper prep. & K.G. Classes), (2) Primary school section (classes I to IV), (3) High school section (Classes V to X), (4) Higher Secondary section (Classes XI & XII). It has two Campuses viz Sepoy Bazar Campus and Rangamati (Tantigeria Mouza) Campus. The school is managed by the Governing Body, appointed by the Society for the Betterment of Education, Midnapore. The School from its very inception depended solely on the tuition and other fees collected from its students. The Society for the Betterment of Education and the Governing Body and its members take interest in the business of the school without any remuneration whatsoever. The Society is under the direct supervision of the District Magistrate and the School Governing Body is constituted by the Society. The ADM (General), Paschim Medinipur is the President of G.B.

Thanks to the sustained patronage and support of the enlightened people of Midnapore for making the school grow over the years into a prominent centre of educational excellence.

**RULES & REGULATIONS**

- Whole year's fees may be deposited at a time. Fees must be paid every month. A fine of 50/- will be charged for payment made after the month gets over.
- All payments are to be made through online at [www.vsn.ac.in](http://www.vsn.ac.in).
- Fees should be paid in advance for the Summer, Puja and Christmas Vacations.
- Pupils whose fees are over six months in arrears will have their names struck off the rolls and will be readmitted on payment of arrears and new admission charges.
- A student who remains absent from school without intimation for 15 continuous working days, will have his / her name struck off the rolls and will be readmitted on payment of readmission charges that are applicable. Non-collegiate fine may also be charged depending on the case of low attendance.
- The students who have cleared the school fees for all the previous months prior to the examinations will be eligible to appear the Half Yearly Examination. To appear the Annual Examination school fees of the entire session till March must be cleared.
- Regularity of attendance must be maintained. Those who will have less than 75% attendance will be barred from taking the Annual Examination.
- Poor and meritorious students may apply for concession of tuition fees to the Principal/ Headmistress (Primary) within three months from the date of admission.
- For obtaining transfer certificate the outgoing student will be required to pay. Rs.1500.00 as certificate fee and monthly tuition fees for as many months as the student will spend in the session in which he/she will take transfer and proportionate annual charges. If, however, a request for transfer certificate reaches our office six months after the beginning of the session full annual charges will have to be paid.
- Half-Yearly and Annual Examination Answer Papers will be shown to the guardians ONLY on the fixed date and only to those who have paid the school fees up to date.
- No student is allowed to leave the school premises without proper authorization. Application for early departure must reach the office of the Principal within 15 minutes of the Prayer bell.
- Pupils are responsible for the safe custody of their belongings and books. Each article should bear the child's name. Books should be covered and labelled.

**CONDITIONS OF ELIGIBILITY FOR ADMISSION TO CLASS XI (ISC)**

1. Secondary Education Examination with passes in five subjects including English and a





second language are eligible to be admitted for preparation in courses of study leading to the Indian School Certificate Examinations.

2. (a) The eligibility of candidates who have been awarded Pass Certificates in an equivalent examination conducted by another Examining Board will be decided by the Chief Executive and Secretary of the Council. The conditions of eligibility are as follows:

(i) The candidate must have been awarded a pass Certificate in accordance with the requirements of the Board at an equivalent examination taken at one and the same sitting.

(ii) The candidate must have obtained pass marks in accordance with the Regulations of the Board in

(a) English (b) a Second Language (as distinct from English) and (c) three other written subjects, accepted by the Council.

**Note: This provision does not apply in cases where the Board does not have provision for the teaching of a Second Language at all.**

- (b) A candidate who has been awarded a Pass Certificate by another Examining Board will be admitted provisionally. If the candidate is found to be eligible, the Council will issue an Eligibility Certificate to the Head of the School concerned in respect of the candidate, only then the admission will be confirmed. If not, the fees paid are non-refundable.

### REQUEST TO THE GUARDIANS

***Parents and guardians are requested to co-operate with the school authorities***

1. by urging their wards to regular and punctual attendance. Irregular attendance is found so unsettling to work and discipline that parents are earnestly requested not to take their children out of school unless reasons are most urgent. Promotion may be refused if attendance is less than 75%.
2. by attending the parent-teacher meetings.
3. by seeing to it that their wards are diligent at their lessons and their home work, if and when it is given.
4. by seeing to it that their wards are neat in their personal appearance and their text books and exercise books are kept clean.

**Parents and guardians are not allowed to see their children or meet teachers during school hours, except under very special circumstances.**

### GENERAL NOTICE

All letters concerning the children's attendance must be addressed to the Headmistress (Primary section) or the Principal.

Except for urgent reasons no one will be allowed to leave school before the last class / last hour of work is over. Application for early departure must reach the office of the principal within 15 minutes of the Prayer bell.

Identification cards are furnished to the guardians. These must be used by those coming to collect the children from the school.

The Principal may be met in the office on school days between 11 a.m. and 12.30 p.m. The Headmistress (Pre-school & Pry. School section) will receive visitors between 8 a.m. and 9 a.m.

Parents are welcome to communicate with the PRINCIPAL / HEADMISTRESS (Primary section) personally, or by letter on any matter concerning the welfare of the children.





## SCHOOL UNIFORM

### Boys:

**Lower Nursery to KG.:** \*Half sleeved chequered shirt in prescribed pattern with school monogram on pocket. Deep grey half pant (with straps over the shoulders), white socks with three grey stripes & black shoes. School belt & tie are also compulsory.

**Class I to Class-IV.:** Same as above\*. Deep grey half pant (without the straps over the shoulders)

**Class-V to Class-XII:** same as above\* with full-length trousers to be used.

### Girls

**Lower Nursery to K.G.:** \*\*Half sleeved chequered shirt in prescribed pattern with school monogram on pocket. Deep grey skirt (with straps over the shoulders), white socks with three grey stripes & black shoes. School Belt and Tie are also compulsory.

**Class-I to Class-IV:** Same as above\*\*. Deep grey skirt (without the straps over the shoulders)

**Class-V to Class-XII:** Same as above\*\* but with prescribed skirt pattern with box-pleats, knee length.

## WINTER

### Boys:

**Lower Nursery to K.G.:** Plain-knitted V-neck maroon sweater with same coloured cap. Full shirt & full length trousers to be used.

**Class-I to Class XII:** Maroon coloured blazer with school monogram and maroon cap or muffler to be used.

### Girls:

**Lower Nursery to K.G.:** Plain-knitted V-neck maroon coloured sweater with same colour scarf, white stockings to be used.

**Class-I to Class-XII:** Maroon coloured Blazer with school monogram on the pocket. Maroon coloured scarf/muffler and gloves to be used.

## HOUSE UNIFORM Only for classes V to XII

White polo neck T-Shirt with school monogram (Collar as per house colour) and white track pants, white canvas shoes to be used.

**Winter:** Maroon coloured sweater to be used.
