j) Conditional tender will not be accepted

### Terms & Conditions

1) An agreement has to be executed with the Principal & Secretary, Vidyasagar Shishu Niketan, Midnapore on a Non-Judicial Stamp Paper of the value of Rs. 100/- (rupees one hundred) only within the date specified in the letter of intimation by the successful bidder.

Work order will be issued after execution of the Agreement.

2) The tender documents and relevant particulars (if any) may be seen by the intending tender on all working days during office hours in the office of V.S.N.

3) Contractors shall have to comply with the provisions of (a) the contract labour regulation abolition act, 1973 (b) apprentice act, 1961 & (c) Minimum wages Act 1948 and the modification thereof and other law relating the rates and the rule made and other issued there under from time to time.

4) Intending tenderer will have to produce valid certificate of upto date clearance of income tax & Sale Tax for being entitled to receive tender documents. Attested Xerox copies of the same be produced which will not be returned.

- 5) The contractor is requested to see the site before quoting rates.
- 6) Work must be completed within specified time.
- 7) Authority reserves the right to reject any or all tenders without assigning any reasons and is not bound to accept the lowest tender.
- 8) In case of the tender whose tender has been accepted and on executing the agreement. Balance total 8% of the total work order value will be deducted from 1<sup>st</sup> R.A. Bill. This amount along with the earnest money deposited and deducted earlier will constitute the security deposit. Such security deposit will be refunded after 01(one) year of satisfactory completion of the whole work. In case of failure to complete the work within the stimulated time, or in case of failure to rectify any defect arising during the security period, the security deposit will be forfeited.
- 9) In the event of the tender being submitted by a firm it must be signed separately by each members thereof or in the event of the absence of any partner, it must signed on his behalf by a person holding a power of attorney authorization to do so.
- 10) The name of the work must be written on the envelope containing the tender.
- 11) This notice inviting tender will be the part of agreement.
- 12) Proportionate quantity of the work is to be done in proportionate time through out the stipulated time of completion.
- 13) Royalty clearance certificate is to be submitted by the contractor with each bill for effecting payment.
- 14) Each page of tender form, tender notice & other documents must be signed by the tenderer before dropping it, with full address in the tender form.
- 15) Contractor have own or have to arrange all Machinery, etc. required for the work.
- 16) The contractor shall keep a whole time competent and qualified representative at work site with intimation to the school, who will receive on behalf of the contractor written instructions through duplicate site order book from the school representative/Engineer.
- 17) No claim for escalation of rates will be entertained.
- 18) TDS as per prevailing norms along with Cess 1% will be deducted from each progressive & Final Bill.
- 19) The rate should be quoted both in figure and in words; in case of any disparity the rate in words will be final.
